## 1. LEGAL BASIS

The General Data Protection Regulation (GDPR) is a new privacy regulation to harmonize data privacy laws. We process your personal data exclusively on the basis of the EU-Regulation as of May 2018.

## 2. GENERAL

# 3. WHAT KIND OF DATA WE COLLECT AND ITS PURPOSE

We collect, process and store data such as:

- Personal data relating to your online shopping activity: first name, surname, mobile telephone number, payment information, billing address, shipping address, product purchased, international VAT number (business clients), IP address

#### 4. STORAGE

We store this data until the statutory or contractual period of retention has expired of if your data are no longer needed for the fulfiment of contract or for complying with legal obligations.
